## 2. Report from Standing Committees

### 2.1 Parks & Recreation

Written Report from Denise Dixey, Parks & Recreation Committee Chair (Absent)

#### 2.1.1 Community Cleanup

**Written submission:** I have spoke to Evan Woolley (CBMCA) regarding joining their clean up. He has not got back to me with the specific date, but he believes it to be a Sunday just after Labor Day, so I would assume it would be September 15 or 22. He thinks joining with them is a great idea. We have time to coordinate and I will follow up after we are done with River Clean Up.

**Kirt:** for anyone unaware of what this is, it's an opportunity for community members to get rid of large rubbish.

#### 2.1.2 River Cleanup

**Written submission:** Registration for the area east of Elbow River between Macleod Trail and 25th Ave Bridge has been confirmed. I will be attending the New Leaders Orientation April 18 with Evan Woolley (CBMCA). We will obtain supplies in addition to latex gloves (generously donated by Talisman Centre) and "picker" sticks (Shirine has these).

I have applied for a Park Permit for our location for May 5. I have paid for the permit when the City called, however I have not received the permit at this time.

We have met with Julie Johnston (Talisman Centre) twice to work out the arrangements. She has produced posters for each community association. Shirine has spearheaded the BBQ and she will be able to report on her progress.

#### **Shirine update:**

- Met with Spolumbo's and they will kindly donate 144 sausages
- Arranged for 20 x 20 tent
- Will receive tables, two canopies and chairs from Talisman Centre
- Shirine will arrange for utility locations

- Worked to get a poster together, will post third week of April (available on erltoncommunity.com)
- Communications sent out to community, asking for volunteers
- Cost of BBQ rental was very high. Evan Woolley from CBMCA will bring his own, much larger BBQ
- Band from last year will also be performing
- The insurance will cover whatever community association signs the contract. Already communicated with Talisman and other community associations to ensure everyone has their insurance in order.
- Lots of sponsors, including sponsorship from Talisman Energy of \$1000; will manage the event within the budget

## 2.2 Development

Report from Bill Fischer, Planning & Development Committee Chair

### 2.2.1 Update on Active Development Permits

Triplex proposed for 78 34 Avenue SW. Developer is now in second or third version of plans. Wanted to meet with Gian-Carlo and Bill Fischer to review. City has identified deficiencies as part of pre-proposal review.

Triplex proposed for 55 28 Avenue SW. City Planning outright rejected, a first since the '90s. Developer is appealing. City's notes up for review on Friday (April 12), Bill Fischer will circulate, post on website. Bill Fischer will review plans and see what our stance as a community should be, with feedback from neighbours.

Question re: 61 30 Avenue (update later from Paul Tye) and Mission Rd development. Any updates? No updates.

### 2.3.1 Traffic Survey
