4.3 Calgary Police Services Community Resource Officer Update

Constable Staples

No major updates, fairly uneventful in Erlton. Pulled some stats looking from January 2013 and January 2014.

- 20 calls in Jan 2013 (traffic stops, accidents, most serious was a break and enter in a shop). 10 calls were for Talisman Centre, 6 were traffic-related.
- 36 calls in Jan 2014 (11 at Talisman)
- 27 calls in Dec 2013
- For comparison 82 in Inglewood, 56 for Ramsay in Jan 2014

Michael: Did anyone take you up on your offer for traffic enforcement? No, please contact me and I can let specific officers know that they can target specific areas.

Heesung: the activity at Talisman could be an increase in Talisman calls because of homeless population, particularly since Alpha House has come back online after the floods. We have been encouraged to log the calls on 311 and/or non-emergency police line. Consensus seems to be there are less homeless sleeping in Lindsay Park, largely due to efforts by Alpha House, police and other groups.

Cst Staples: during the last homeless count in the summer of 2013, I only counted 2 homeless.

Denise: Getting lights fixed and shrubs trimmed has made a big difference.
