#### 5.3.1 Membership Activity Update

- Canvassing started in August to end of September
- 138 members and had some last-minutes additions, could go as high as 148.
- New members: 11
- Only 2 declined purchasing memberships
- 17 senior members, 4 senior but paying
- 129 emails for members

**Question from community**: how do you notify community members who do not have email addresses? **Shirine**: sandwich boards are put up on 25 Avenue and Erlton Street and 34 Avenue and Mission Road just before the meeting.

#### 5.3.2 Spring Newsletter

Usual delivery is in April to rally people to get involved, particularly with River Cleanup. The newsletter is a visible sign of the ECA's presence, looking to get people to volunteer in the community, particularly for River Cleanup.

#### 5.3.3 River Cleanup BBQ

Over 100 sausages were BBQ'd, predominantly paid for by Talisman Energy, Spolumbo's and the Talisman Centre.

#### 5.4 Parks & Recreation

Report from Denise Dixey, Director, Parks & Recreation

#### 5.4.1 River Cleanup

Over 100 volunteers participated, done in conjunction with Mission and Rideau-Roxboro communities. We did not win the most interesting find this year. Great to see the support for the community is strong for the event. Paperwork has already been filed for the event on May 4, 2014, with a rain day of May 11, in case of inclement weather.

## 5.5 Planning & Development

Report from Bill Fischer, Planning & Development Committee Chair

#### 5.5.1 Residential Development Activity Update

Over last 12 months, we saw 10 new permit apps. Community comments are all available on erltoncommunity.com (<a href="http://erltoncommunity.com/development-planning/">http://erltoncommunity.com/development-planning/</a>)

#### 5.5.2 Anthem Properties (25 Ave / Macleod) Development Update

City has a re-zoning application in to revise by-law that governs property. Only outstanding item concerns traffic management in the area. A traffic study has been requested by the City, which Anthem will produce. Community will provide input on whether commercial tenants will be allowed to run commercial traffic on Erlton Rd. Once study is in place, will distribute to residents and gather feedback.

**Question from community**: how will you gather feedback? **Bill**: see site (<a href="http://calgary.ca/erltonroad">http://calgary.ca/erltonroad</a>) to provide your input. On the same site, our contact info is on there. No responses yet.

**Question from community**: we were unclear on how to provide our feedback at our Waterford AGM. **Bill**: we will send an email to condo presidents and gather feedback (see previous URL (website link)). In addition, the City has put up a sign at the corner of Erlton Rd. and 25 Avenue with the URL.

**Councillor Carra**: in your report you mentioned Anthem is interested in running commercial road along the street; my understanding is that 24 Avenue will become a mixed-use street. Along the Macleod Trail side, there will be access to the parkade. The request is to change the use so that traffic will enter on 24 Avenue rather than go around Erlton Rd. **Bill**: one other aspect, the commercial traffic should be going right off Macleod to 25 Ave and right on to Erlton Rd. Question is really how much commercial we want, not whether we can stop it completely.

**Kirt**: we'll shelve this for now, but please visit the site for more info. Please email Bill directly for info.

**Natalie**: please check in with your condo presidents, make sure Bill has their correct contact info.

#### 5.6 Traffic Subcommittee

Report from Jeremy Yawney, Traffic Subcommittee Chair

#### 5.6.1 Survey Results and Action Plan

A majority of respondents (54% vs. 23% who said no) believe Erlton has a traffic problem. Key issues identified include:

- Shortcutting through the community (i.e. 27/28/31 Ave)
- Safety concerns due to the chicane at the top of Erlton Street near 30 Ave
- Speeding on Erlton Street

More respondents are concerned that the Anthem development will cause additional traffic problems than those who do not (42% vs. 29%)

Respondents were fairly split on whether Erlton has a parking problem (38% believe there is, 32% believe there is not). Key issues identified include:

- Lack of parking/congestion during Stampede
- Safety concerns caused by parking in the chicane at the top of Erlton Road

**Kirt**: coming together with an action plan was in the 2013 plan, but we'll carry it over into 2014. If you're interested in participating, talk to Jeremy or myself to get involved. **Councillor Carra**: my office can work with anyone who has issues.

**Question from the community**: what's the status of the interchange at 25 Ave and Macleod Tr. **Councillor Carra**: been on the books for a while, still nothing certain about there being an interchange. Personal preference is to bury the LRT to simplify traffic. Always surprised when I go over Macleod and how Cemetery Hill separates Erlton from the area.

#### 5.7 Post-Flood Action

Report from Geoff Granville, Post-Flood Action Committee Chair and others

#### 5.7.1 Community Outreach Update

4 Key areas: Prevention, Preparedness, Response, Recovery. There has been much involvement from all levels of government. If you have questions, please come see me. Volunteers made this much better. Councillor Carra's office and Calgary River Communities Action Group have been and continue to be highly involved. Trish and Danielle stepped up a couple of months ago and asked: how do we get more involved, so the result was more information and resources on our site.

**Councillor Carra**: Lindsay (Ward 9 Constituent Assistant Lindsay Luhnau) is very much involved in helping with those affected and there's lots going on.

**Danielle Krause**: a few of us have gone door-to-door and met with owners/tenants and helped them get in touch with appropriate organizations to come up with solutions.

**Trish Herreira**: lots of involvement from multiple organizations, governments, etc. to assist.

**Councillor Carra**: community response in Ward 9 was great, kudos to Danielle for work on the ground. Regarding resiliency, what really got us through was the community. When the City called out for volunteers and they were overwhelmed, they realized the communities have enough energy and not to get in their way. There's currently an idea floating around of getting some kind of disaster planning representation on community associations. **Kirt**: that would be a good item to add to our 2014 action plan.
