According to our by-laws, the financial year runs from July 1, 2013 to June 30, 2014. This is a transition year because in the past we have been showing the year from November 1 to October 31.

As of June 30,2014 our net worth was \$23,102.53. After the membership drive in August to September, that brought in \$1,270.00, and all the accounting was done for the Neighbor Day party and the Little Library launch the net worth as of today is \$23,979.51.

I would like to thank the Red Cross and the City for the donations that made it possible to have the two parties at no cost to the ECA. Many thanks to Michelle Smekal who organized the parties and produced detailed budget reports.

I completed the Society's Annual Return and it is ready to be sent to the Registrar of Corporations along with the 2014 financial reports.

13 Development Permit Applications handled. Two appeals - both successful. Two appearances before City Council relating to Land Use Bylaws. Unsuccessful in having the bylaw for Mission Road rejected, although Councillor Chabot voted against it and commented that it didn't pass the smell test. Unsuccessful in amending the Anthem bylaw in North Erlton to maintain residence only usage for Erlton Road, and eliminate short cutting from MacLeod Trail to Erlton Road via 24 Ave.

Traffic Subcommittee, Jeremy Yawney

Continue to work with Gordon, Janet and Anita. In contact with Anthem through their representative, Rocky. Met with our councillor to discuss our issues and put forward a letter to him as per his request, outlining ECA concerns. Asking for a comprehensive traffic study affecting the entire community. Still awaiting for response regarding six or seven issues. The Mission project is going ahead with the ground breaking last week.
