    - Another member indicated that it's usually because these people are misinformed.
    - It's not one person's decision what happens in the community, there are votes that take place either within the Board meetings or within community meetings, so blaming decisions on one person is incorrect.

- River cleanup needs additional volunteers for after the cleanup (the social part) doesn't have to be a big bbq, just a coffee and doughnuts thing
- Member suggestion that Humpty's or Safeway may donate
- Could also buy as it doesn't have to be expensive

## iv. Planning and Development: Bill Fischer

- Application for new home 2508 Erlton Street
  - We got a preview of this when the owner came in to present the project at an ECA meeting
  - o 3-storey, loft, 2-car off lane, secondary suite on main floor
  - One of neighbours has already indicated objection to height it's over the limit
  - O Not going to be as high as the one on the corner of Erlton St/27 Ave
  - o Planning committee will look over in details and give comment to the City
- City doesn't provide details of relaxations that are being asked for this is a change that went through around 2 years ago.
  - City said they'd monitor it, but we're not so sure this is happening
  - So the community association has to go through all the plans in detail to see what is against the rules, only to be told there has been a relaxation
  - BIG job for a volunteer planning committee to do (basically doing the City's work for free)
  - Comment: Would be helpful to get community associations to have a petition to get more transparency of this?
    - Planning committee has been working on trying to convince the City to give us these details for a while
  - Ward 9 Gian-Carlo Carra has no comment on this.

#### v. Traffic: Rob Lukacs

- Not present
- Looking at potential traffic calming measures in South Erlton
- Looking at most cost effective, easiest to install etc.
- Will be creating a survey for all residents
  - o There's a group called Slow down YYC trying to get the speed limit reduced.
- Natalya brought activity for after the meeting highlighting pathways that should be well-lit etc. or improvements of pathways.

#### 3. Ongoing business

- Anthem and City have come to an agreement on the contribution Anthem will make on the overpass to the station
  - Haven't heard whether it's still in Phase 2 or whether that's changed
  - Rocky from Anthem will call a meeting sometime in the next month
  - Sales centre will be installed soon on the site
- Jane's Walk: still need stories from people for the walk and volunteers to put it all together
  - One of the meeting attendees volunteered to help out her email address was taken

# 5. New business

- Community Objectives Workshop (COW): Sat, Feb 20<sup>th</sup>: 10:30 2:30
  - Trying to engage as many people as possible
  - Currently not many participants from Erlton, mainly Rideau and Parkhill, so more diversity is needed
  - Food and entertainment provided

- Feasibility Study Macleod Trail / 25 Ave
  - What's the community's thoughts on releasing those lands reserved for overpass/underpass and putting other ideas on the table?
    - City owns corner lot on the space where Anthem will be building
    - Comment: Why wouldn't they keep the flexibility and keep the land? Is there a pressure from Anthem?
    - Comment: If we're against the interchange proposal, maybe we say to get rid of it so that there's no chance of this
    - Natalya to go back and ask further questions to Stephen before we make a motion

#### Additional comments:

- Comment about someone on a resident's street trapping rabbits and sending them to the SPCA
  - O What's the regulation on this?
  - Our community has a love/hate relationship with the rabbits ;-)
  - o People are allowed to feed them, and trapping them on their own yard is probably ok
  - People are seeing coyotes and bobcats again
