- Came to talk about the River Access Strategy
  - Looking into specific access points or loading areas
  - In addition, with all the people accessing the Elbow, banks are getting damaged.

  - Discussion about River access sites – they need them to be safe, legal, resilient to floods, with garbage, washrooms etc.
  - Education and promotion opps (e.g. where to not go, watch for fish etc.)
  - Train people to be ambassadors for the river
  - Volunteers – environmental stuff
  - Economic Opps – people come here especially to fish??!!! They're complaining about the E.coli
  - E.coli measures are WAY above safe level in the Elbow and will be for years.
  - Main aim is to push people to the Bow
- Comments about whether there should be any recreation at all on the river – because of the environment, damage and health – most major cities do NOT have recreational access to their main river
- Comment about how there shouldn't be any access in our area (in this plan there seem to be 4 suggested points – if we include Lindsay Park)
- Maybe we could write a letter on behalf of the community?
- Comment - Environmental focus is a priority
- Comment – traffic and parking is already an issue in this are
