# April 2017 Meeting Minutes April 11th: 7:00pm

The April meeting of the Erlton Community Association (ECA) was an information meeting only, due to a lack of quorum, at the opening and close, and there were no items to be voted on. It commenced at 7:05 pm.

# 1. Approval of Agenda

Agenda accepted without changes.

#### 2. Presentation of the Minutes

No changes were suggested for March 2017 minutes.

# 3. Guest Presentation by Nolan Tudor of the Tech Shop

Nolan spoke about the three types of feet: 1) neutral -70% of population; 2) Over-pronated-28%; and Under-Pronated -2%. He passed around examples of running shoes for different foot types and running/walking conditions, and gave a brief overview of optimal running form. All ECA members are eligible for discounts with their membership card and he distributed a \$25 coupon to attendees.

#### 4. Information Items

#### a) President's Report: Viccy Grace

Viccy has been promoting community events and collecting data from the March meeting to plan Neighbour Day. She has put a call for ideas and volunteers for Neighbour Day in the Elbow Scene. She attended a Planning workshop offered by the Federation of Calgary Communities (FCC) and a meeting on Flood Mitigation. See item 4.d.2 below.

# b) Vice-President's Report: Krista Goranson

As Krista was absent, there was no report.

#### c) Treasurer's Report: Mona Hayes

As Mona was attending an FCC Workshop for Treasurers, there was no report.

# d) Directors Reports

### i. Membership: Danielle Kraus

There are 70 current regular members; 4 paid senior members, and 16 complimentary senior members. Volunteers are needed to sell memberships at the River Clean-up on May 7<sup>th</sup> and Neighbour Day on June 17<sup>th</sup>.

# ii. Post-flood Action Committee: Dean Campbell

Dean handed out a document "Flood Mitigation Measures Assessment Report and 2016 Flood Resiliency Update" dated March 22. There were five recommendations, but only three of them pertain to Erlton: #2: Continue supporting the development of the Springbank Off-Stream Reservoir on the Elbow River; #4: Explore the development of

property level mitigation program, and #5: In alignment with Provincial Mapping and policy updates, conduct further investigation on land use policy and building regulations for areas prone to flooding. The Springbank Off-Stream Reservoir is supposed to be in place by 2020 and will mitigate 25% of the flood levels experienced in2013. However, some groups are opposed and a federal environmental assessment will be conducted. It will be very important that Erlton make its voice heard in the public engagement process. Dean will look into the possibility of getting on an email list for updates.

# iii. Planning and Development: Bill Fischer No report.

# iv. Traffic: Natalya Nicholson

The plan proposed by the city to install two speed bumps each on 27<sup>th</sup> and 28<sup>th</sup> Avenue and sidewalks on both sides of Erlton Street between 31<sup>st</sup> and 34<sup>th</sup> Avenue was discussed. The consensus was that a sidewalk on only one side was necessary, preferably on the east side. Instead we would like to see the better marking and perhaps a railing for shallow steps in the sidewalk on the east side of Erlton Street between 28<sup>th</sup> and 29<sup>th</sup> Avenues. It was suggested that the No Parking zone between on Erlton Street near 30<sup>th</sup> and 31<sup>st</sup> Avenue be moved slightly north, and that a painted pedestrian crosswalk (without lights) be installed at 31<sup>st</sup> Avenue. Reducing the speed limit in this section of Erlton Street to 40km was also suggested. Natalya will continue to survey those residents most impacted by the changes and will send out a revised map.

# 6. Ongoing business

# a. Neighbour Day - June 17

Viccy is compiling the ideas received at last month's meeting for this celebration and will be meeting with Julie Johnston of the Repsol Sport Centre to discuss using that site. All permit fees are waived by the City.

#### b. Mill Street Brewery 17 Avenue Tour – March 23

Although the turnout was less than hoped, those who attended had a great time. As there was no upfront costs involved (participants simply paid \$10), it may be worth trying again at a future date.

# a. Erlton Bunnies Attracting Coyotes

A resident reported that a coyote appeared on her steps chasing her dog and she feared for the safety of her small children inside the house. Rosanne Pinchin has contacted Tanya Hope who responsible wildlife management for the Parks Department. We may be able to have an expert from the University of Calgary speak to us about this issue at our next meeting. Our Councillor Gian Carlo Carra is aware of the issue.

A full report of two community engagement sessions held in November 2016 with 43 community associations represented is now available. A report of the October 2016 survey of 85 external partners is also available.

READYCalgary is an emergency preparedness program encouraging safety at home, in the workplace, and in the community. A session for individuals and families is being offered on May 16<sup>th</sup> and a more advanced session for those interested in helping their communities will be offered on May 23<sup>rd</sup>.

The City has just approved a program of micro-grants for communities to make their neighbourhoods more pedestrian-friendly. Rosanne will have more information next month.
