Subject: Chevra Kadisha of Calgary, Jewish Memorial Chapel

On north side of 30th Avenue S.W. there is a cemetery belonging to the Jewish faith and it is managed by the Chevra Kadisha of Calgary, Jewish Memorial Chapel. In the late eighties they had approached the City of Calgary indicating that they want to expand into the full block tucked in between 29th Avenue S.W. and 30th Avenue S.W. This subject is more than 30 years old, there are only hand full of people from that era still residing in Erlton. I am one of them and I felt it is important for the current residents of Erlton that joined in post 1980's to know the history. Particularly in light of the demolition that took place on May 11-14, 2021 at address 32 30 Avenue S.W. If they wish to make a decision it will be an informed decision. In late eighties Chevra Kadisha had made a proposal to the City of Calgary to expand the cemetery by purchasing homes on address 51,53,55 29 Avenue S.W. and 2804 Erlton Street S.W. In the proposal they had designated the corner house on 2804 Erlton Street S.W. as the cemetery care taker's house. The reference was made to my house. None of the home owners knew about this proposal and found out in directly and not through Chevra Kadisha. After their plan was reviled they made their offers . The offers were far below market price and unattractive. Thus no one wanted to sell. And we decided to go against the expansion. We got the whole community and ECA supporting us we went to our Alderman (Councilor) the late Mr. Barry Erskine.

Mr. Erskine listened to us and said that Chevra Kadisha is a powerful organization and we stand no chance of winning if we took our case in front of City Council. He suggested we go through a mediation process to resolve our issue. That is what we end up doing and after three mediation sessions the following agreements were reached and signed off.

- 1) City of Calgary will sell at a nominal price the boulevard along the north side of 30th Avenue S.W. allowing the cemetery to expand in that space.
- 2) Chevra Kadisha will commit to no further expansion in Erlton. Particularly in light of the new Erlton LRT station and the requirement of establishing high density living areas.
- 3) Chevra Kadisha will build a new house for the cemetery care taker on the lot at 32 30 Avenue S.W. This house will provide a buffer between the cemetery proper and edge of Erlton Street and maintains the residential continuity in Erlton. That was important for our small community that was segmented with large parcels of cemetery.

This process took few years and it was legally finalized in 1995.

Fast forward to May 10, 2021 that I received a letter from Chevra Kadisha announcing the demolition of the care taker's house. I immediately contacted Chevra Kadisha, Councilor Farkas office, 311, demolition permit office and technical city planner to ask for a pause to the demolition and find out what happened to the mediation agreements. In less than 24 hours the house was demolished and all traces removed. Despite their current claims, I am certain that Chevra Kadisha intends to expand the cemetery in to the vacant lot. Another word, after 30+ years Chevra Kadisha has reneged on two of the three mediation agreement points. I consider this act an assault to Erlton, ECA, City of Calgary and it has to be stopped in its track minimizing the damage. For that I need you support. If you are busy with other development a sub-committee can be formed to deal with this matter only and I will sign up to it.

I have reviewed documentation issued by the city post 1995 and they contained glaring errors. First the city has to be approached and held accountable for operating outside the mediation frame work. Prior errors have to be corrected and brought to attention of Chevra Kadisha. Meanwhile city has to ask Chevra Kadisha to halt all operations in the vacant lot until matters are resolved. Second Chevra Kadisha has to be held accountable for deviating from the mediation agreement points. Once again actions must be taken to stop further expansion in Erlton and it has to be made ironclad.

It is imperative to recognize that any future works has to be conducted with in the mediation frame work. This subject has to be dealt with as a whole and cannot be broken into separate parts. For example, the city cannot pay 30,000 to Chevra Kadisha, reclaim the boulevard and allow Erlton to have the boulevard back along 30^{th} avenue. Similarly Chevra Kadisha cannot break away from their end of the bargain. This is the true meaning of mediation.
